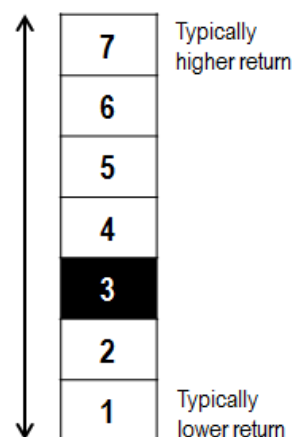

## Main terms and conditions of the investment basket

- **Name:** Mandatum Life Emerging Markets Bond Index
- **Portfolio manager of the investment basket:** Mandatum Life Insurance Company Limited (Mandatum Life)
- **Target market of the investment basket:** Emerging bond markets
- **Primary investment object of the investment basket:** iShares ETF (denominated in US dollars) which invests in the Barclays Emerging Markets Local Currency Core Government Bond Index
- **Capital protection of the investment basket:** The investment basket does not have a capital guarantee.
- **Start date of the investment basket:** 20 December 2013
- **Sales period:** Continuous
- **Investment period:** Continuous
- **Value of the investment basket unit:** A value is calculated for the investment basket unit on each banking day.
- **Annual management fee of the investment basket:** 1.00%

## ML Index investment basket

Mandatum Life's Index Investment Baskets are based on index products provided by BlackRock iShares.

An ETF (Exchange Traded Fund) is a fund that is traded similarly to listed equities. ETFs have real time price formation on the stock exchange and just one ETF trade is enough to achieve instant diversification for the investments.

The objective of an ETF is to track the return on the benchmark index assigned to it, by purchasing the

index's securities either in the same proportion as in the benchmark index or by purchasing them in an optimised manner, if it is not possible in practice or sensible to buy all of the securities in the benchmark index.

The benefit offered by an ETF is its broad diversification across its target market, its low cost structure in accordance with a passive investment strategy, liquidity and the transparency of the investments.

The ML Index investment basket strives to, by buying into the iShares Emerging Markets Local Government Bond UCITS Index

Fund (Investment Object), track the Investment Object's target market as closely as possible and thus to offer the investor a corresponding total return of the Investment Object's target market. The iShares Emerging Markets Local Government Bond UCITS ETF invests in emerging markets government bonds. Thus the Investment Basket offers a comprehensive sample of emerging markets government bonds.

## Investment strategy

The investment basket's assets are primarily invested in iShares Emerging Markets Local Government Bond UCITS ETF (Investment Object), which tracks the Barclays Emerging Markets Local Currency Core Government Bond Index. The investment basket may also include a small amount of cash.

The portfolio manager can use the Investment Object for trading in the market place of his or her choice. The portfolio manager can exchange the Investment Object for another ETF or index fund managed by BlackRock that tracks the Barclays Emerging Markets Local Currency Core Government Bond Index if the liquidity or other quality of the Investment Object changes. Changes in the Investment Object are reported on the Insurance Company's website.

Any coupon possibly paid by the Investment Object and other returns are reinvested in the Investment Object.

As the Investment Object invests in securities other than euro-denominated ones, the investment basket is subject to foreign exchange risk related to the Investment Object's target market.

## Target investors

The investment basket suits investors who seek a broad diversification for their investments, typical returns for the emerging market bonds and accepts the risk of losing return and capital. The recommended investment period is at least 5 years.

## Calculation of the investment basket's net asset value

The net asset value of the investment basket is calculated by deducting liabilities of the investment basket, including management fees and expenses associated with investments, from its assets. The investment basket's investment object is valued at the current market value on each banking day. The value of the investment basket is available on Mandatum Life's website.

The value of redemptions made from the investment basket will be determined per order in accordance with the market situation at the time of redemption.

## The investment basket's risk profile

The investment basket is exposed to the emerging bond markets' return risk and capital risk as well as foreign exchange risk. Return and capital risk mean that the investor may lose the capital that he or she has invested as well as the returns in part or in full.

The value of the investment basket is calculated regularly based on the current market values of the investment objects it contains. Changes in the bond, foreign exchange and interest rate markets are reflected in the value of the basket, which can vary substantially in the short term.

The investment basket is not covered by the investors' compensation fund or the deposit guarantee fund.

## Investment basket's fees and expenses

The annual management fee of the investment basket is 1.00%. The investment basket's management fee includes the Investment Object's management fee.

The investment basket's management fee and possible other expenses associated with underlying investments, including safe custody expenses, subscription and redemption fees, trading costs and any taxes and other public charges will be deducted daily from the value of the investment basket when the value of the unit is calculated; they will not be charged separately from the policyholder.

## insurance policies
